Note: A Census Designated Place is an unincorporated place or hamlet with boundaries defined by the Census Bureau utilizing blocks and block groups. The boundaries are not legally established or recognized and may change from one census to the next, leaving comparisons between censuses limited and possibly inaccurate.

Note: Numbers in parentheses denote a negative change. Percentages may not add up to exactly 100 percent due to rounding.

Note: The Group Quarters population consists of people who do not live in housing units and are categorized by two general types: institutionalized population and noninstitutionalized population. The institutionalized population includes people under formally authorized, supervised care or custody. The noninstitutionalized population includes people living in group quarters other than institutions, such as college dormitories or group homes.
